Residents 64 years of age purchase special licenses. See page 5.

Residents 65 years of age and over are exempt from buying hunting, freshwater and saltwater fishing licenses, WMA licenses, and state duck stamps providing that said resident has on his/her person while hunting or fishing an Alabama driver license or proof of permanent Alabama residence and age.

Harvest Information Program (HIP)

All licensed hunters who hunt doves, woodcock, rails, snipe, coots, ducks, or geese in Alabama are required by Federal Law to obtain a HIP permit prior to hunting. HIP permits are free and are available at <http://www.outdooralabama.com> and all hunting license vendors.

Antlered Buck and Turkey Harvest Record

A mandatory hunter harvest record is in effect for the 2007-2008 season. It is illegal for a hunter to field dress or move an antlered buck or turkey before dating a hunter harvest record. See Appendix A.

If someone other than the hunter is transporting a harvested antlered buck or turkey, the individual transporting the antlered buck or turkey MUST have in their possession written documentation including name, address, license number (if applicable), telephone number, date of harvest and signature of the person who harvested the antlered buck or turkey, until it is processed and stored in a cooler or freezer at one's residence or delivered to a commercial processing plant.

Hunter Education

The Wildlife Heritage Act of 2007 passed by the Legislature has provided a mentor provision for hunter education. Now, hunting license buyers have the option to hunt under the "supervision required" status in lieu of passing the hunter education course. Hunters under supervision must be under normal voice control, not to exceed 30 feet away from a properly licensed hunter 21 years of age or older. Under no circumstance shall the supervising person be the holder of a "supervision required" license.

Successfully completing an approved hunter education course is mandatory for all non-supervised hunting license buyers born on or after August 1, 1977, except APOST certified law enforcement officers employed in the state, active duty U.S. Military personnel and Alabama residents who are active members of the U.S. National Guard. Alabama is one of 49 states which has a mandatory hunter education program. Course is a minimum of 10 hours of instruction in addition to an examination. Course content includes hunter responsibility, wildlife laws, wildlife management and identification, firearms safety, archery, muzzleloading, basic survival and first aid. Goals of the hunter education program include increasing awareness of the importance of hunter-landowner relations, hunter behavior, reducing accident rates and increased knowledge of basic wildlife management concepts and wildlife laws. This course is also available on CD-ROM and the internet at www.outdooralabama.com.

Social Security Number Requirement

Section 30-3-194(a) Code of Alabama 1975 provides: "[A]ny agency charged with the administration of any law concerning the issuance or renewal of a license, certificate, permit, or other authorization to drive a private or commercial motor vehicle or to engage in a profession, occupation, or recreational, sporting, or commercial activity shall require all applicants for issuance or renewal of the license, certificate, permit, or other authorization to provide the applicant's Social Security number to the agency, which agency shall record the Social Security number on the application and related records maintained by the agency."

This law was passed in response to 42 U.S.C.A. § 666(a)(13)(2003) which states that the social security number of "any applicant for a professional license, driver's license, occupational license, recreational license, or marriage license be recorded on the application."

The social security number does not have to be entered on the original license. However, the applicant's social security number is required to be legibly written on the second and third copies of the license.

This is a **mandatory** requirement due to both Federal and State law. A license **may not** be issued without the social security number being recorded as stated above.

Notes to Nonresidents

Applicants holding a nonresident driver license will be considered a nonresident for the purposes of purchasing a hunting or fishing license even if they are able to produce other evidence of residency (with the exception of active duty military).

An all game license is required to hunt deer or turkey.

Special fishing license fees apply to residents of Louisiana and Mississippi due to reciprocal license costs.

Game fish cannot be caught by any method other than ordinary hook and line, fly, troll, or spinner. The sale of game fish taken from public water is prohibited by law in Alabama.

Residency Requirements

It is a violation of state law to willfully or knowingly make a false statement when purchasing an Alabama resident license.

Military personnel, their spouses and dependents, with an out-of-state driver license must have a copy of Orders of Assignment to Alabama and a valid military ID to purchase licenses at the resident rate.

College students must present an Alabama driver's license to obtain a resident license. In the case of a college student who is a non-driver, they must present at least two of the documents listed below.

Alabama law requires license agents first ask to see the applicant's driver license.

Hunting and Freshwater Fishing

Only the Probate or License Commissioner's Office can sell a *Resident Hunting or Fishing License* to an individual using the listed exceptions to prove residency. Residents over 16 years of age **without an Alabama driver license or a state issued non-driver identification card** who desire to purchase an *Alabama Resident Hunting or Fishing License* must submit AT LEAST TWO of the documents listed below to the Probate or License Commissioner's Office to prove Alabama residency. In no instance will a resident of another state be issued an Alabama resident license even if the person is able to produce these items.

Residency Requirements

(continued)

1. Copy of previous year tax return (mailing address only).
2. Voter registration card.
3. Certificate of employment, if containing proof of permanent residency.
4. Copy of home property tax.
5. Health insurance forms with address (Medicare) etc.
6. The last three months of a utility bill with mailing address.
7. Other legal documents that may establish residency after approval by the Conservation Department.

Note: The Probate or License Commissioner's office may require more than two of these items in order to prove bona fide residency.

Saltwater Fishing

You must be a resident of Alabama for 90 days prior to buying a resident saltwater fishing (rod and reel) license. All other seafood licenses require residency for 12 consecutive months.

Applicants over 16 years of age without an Alabama driver license or a state issued non-driver identification card who desire to purchase an *Alabama Resident Saltwater Fishing License* must submit AT LEAST TWO of the documents listed below to prove Alabama residency. In no instance will a resident of another state be issued an Alabama resident license even if the person is able to produce these items.

1. Copy of previous year tax return (mailing address only).
2. Voter registration card.
3. Certificate of employment, if containing proof of permanent residency.
4. Copy of home property tax.
5. Health insurance forms with address (Medicare) etc.
6. The last three months of a utility bill with mailing address.
7. Student ID plus copy of residency agreement, or any other proof of residency listed. If the student has a driver license in another state then they are considered a nonresident for hunting license purchases.
8. Copy of school registration for non-driver students. (REQUIRED)
9. Other legal documents that may establish residency after approval by the Conservation Department.

Note: The license official may require more than two of these items in order to prove bona fide residency.

ANTLERED BUCK AND TURKEY HARVEST RECORD

A mandatory hunter harvest record is in effect this season. It is illegal for a hunter to field dress or move an antlered buck or turkey before dating a hunter harvest record. (see example below) this record will be provided on all licenses. For license exempt or lifetime license hunters, a sample form is provided below.

If someone other than the hunter is transporting a harvested antlered buck or turkey, the individual transporting the antlered buck or turkey MUST have in their possession written documentation including name, address, license number (if applicable), telephone number, date of harvest and signature of the person who harvested the antlered buck or turkey, until it is processed and stored in a cooler or freezer at one's residence or delivered to a commercial processing plant.
